

## Marvel Universe LIVE! Rotterdam Competition Terms and Conditions

1. The competition opens at [20.00] on [18 augustus 2016]
2. The competition closes at [24.00] on [31 augustus 2016]
3. **NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN.**
4. Entrants must be legal residents physically residing in the Netherlands who are 18 or older, and are fans of the Page (described below). LIMIT: ONE ENTRY PER PERSON. Employees of competition sponsors and prize suppliers, and the immediate family members of such employees, are not eligible.
